Zephyr Owners Association (Incorporated)

This issue of West Wind brings another season for the Zephyr Class. Over the winter the ZOA Annual General Meeting was held in conjunction with the Auckland Owners at the French Bay Boating Club. Officers elected were Alex Aitken, President, Rob Ebert, Secretary, with Dennis Craig (Ak) Richard Ineson (Chch) and Bill Ackland (Wgtn) making up an Executive.

The ZOA became an Incorporated Society in 1964, by registering its Constitution under the Incorporated Society's Act. As a result, the ZOA can trade on its own behalf for the benefit of members, and any liabilities are restricted to the assets of the Association.

Local owners groups grew up to promote the class in various geographical regions, but operate without the protection of Incorporation. Over the last year, Alex and myself have put considerable effort into ZOA, seeing it as the logical structure, in an increasingly commercial world, to address the long term development of the class.

YNZ addressed the issue of declining club and class membership as a key issue in this year's Annual Conference. Various speakers observed that declining membership was a problem confronting many clubs in New Zealand. The agreed key to turning this around was for clubs to understand their market, and respond by giving members what they want. It comes down to making people feel welcome and giving them a sense of belonging. As New Zealanders' needs and leisure opportunities change, we will need to understand our "customers" at a local and national level.

As President, Alex Aitken has articulated a need for the ZOA to operate in a professional manner. Over the last year, an informal executive tidied up many aspects of class administration, all reported on at the AGM as required under our Constitution. This year, we will be seeking more ways to get new people into Zephyrs and more Zephyrs out on the water. Our great vulnerability though, is subscriptions. Obviously, they pay for the stamps, newsletters, etc, and provide a fund for initiatives on behalf of the class. More importantly, though, they are a tangible indication that members appreciate the time and effort we put into the national and local associations. If you have not paid a ZOA sub of \$15.00 this year as well as \$10.00 to your local branch, please do so. We would appreciate it.

This issue also contains information about the Easter 1998 National Championships at Waiuku. Interest in the Nationals is building in the North Island, so early indications are for a good turnout. Mike O'Connell, as Commodore of the Waiuku Club, is already planning what should prove to be an enjoyable event.

We have a somewhat cramped issue of West Wind this time, almost warranting another page. There has not been much space for news from the regions, so reports of opening activities will have to wait until next time. Until then...

FROM THE PEN OF ALEX AITKEN

National President

Throughout the country meetings of local ZOA Associations and the National body have "Charted the Waters" for the season ahead. By the time you read this edition of "West Wind" a number of clubs will have had their opening days and the wheels of many launching trolleys will have been oiled.

The Zephyr Class of sailing dinghy is recognised as a one-class boat. There is a degree of enthusiasm and we have seen a number of boats change hands and come out of the woodwork. All the club openings I have attended talk about the need to attract young people and families to join up and enjoy the sport of sailing. **You can help** by getting the Zephyr out on the water and showing it off as a nice boat to sail. It can be bought for a modest sum or you can buy a new cedar hull and use existing or new rig to sail for pleasure or in club and national competition.

This brings me to talk about funding. Comments have been by other classes that a strong national organisation is the key to the continuing success of the class. Over the last couple of months I have attempted to convey this message to all local ZOAs. You will see by the financial budget set for 97/98 that your National Association is striving to get all "Zephyr sailors on Board". Your association has agreed to collect the National subscription and the local sub, with one payment of \$25.00. Could I make a plea for support and ask you to post your cheque early in the season to your local secretary.

If you have any queries please contact your ZOA representative. I will not bring up this subject again unless the need is critical.

Rob Ebert has noted a number of items including hulls, masts and sails. There is a responsibility of your national body to uphold the standards as laid down in the class rules. Could I comment on the Masters games in Dunedin next February. Canterbury sailors are keen to go and we should have at least 10 Zephyrs to show the flag. There is interest in Otago and this will be a good public relations exercise.

The meeting followed the Auckland Zephyr Owner's Association AGM, and commenced at 2050hrs.

Minutes

The minutes of the previous AGM were read to the meeting. As the previous AGM had been held in Canterbury, they had been confirmed at a subsequent meeting of the CZOA.

President's Report

Alex Aitken welcomed all those to the meeting, and introduced his report. This had been circulated to the meeting and taken as read by assent. It was acknowledged that the improved membership figures for the Association were due to Alex's efforts.

Financial Report

Alex Aitken circulated and presented his Financial Report. Accepted Aitken/Smith.

Queries

- **Mould Costs:** The original cost of the Zephyr moulds was inquired about, but was unknown. Royalties on new hulls: Alex had allowed a Royalty of \$200 in the hull price, to cover the cost of replacing the mould. This allowance was discussed, and referred to the incoming Executive for consideration.

Budget

Alex Aitken then presented the Budget for the coming year. The mould was uninsured at present. AZO had originally undertaken to pay the \$200 insurance on the mould, but did not ratify this at the preceding AZO meeting. The \$200 donation from AZO shown on the projected budget was thus deleted, and the income total modified to \$1705. With these modifications, the Budget was accepted. Burton/Craig.

Election of Officers

The following Officers were elected:

President: Alex Aitken - Burton/Retter

Secretary: Rob Ebert - Aitken/Waterer

Executive: Dennis Craig (AZO), Bill Ackland (Wgtn), Richard Ineson (CZO).

It was suggested that the AGM should be held at the National Contest, where there is a larger gathering of owners.

General Business

- **Sails:** A letter was received from Chris McMaster of Boyd & McMaster confirming that the traditional Zephyr sail has been transferred to a computer plotter. The next batch of sails will be produced using the new method. The ZOA has in stock a brand new 1983 sail that will be compared with the new ones as a check on construction. It was felt that the consistency of sail shape would be superior with the new method.
- **Masts:** Dennis Craig advised the meeting that Barry Saunders of Bay of Island Spars and Rigging was now the supplier of Zephyr masts. Barry had previously worked for Baverstock and Spar Specialties, and was familiar with the original Baverstock and current McKechnie sections.
- There was concern about the quality and consistency of the masts with the change of supplier. Dennis Craig was asked to satisfy himself that the new supplier of Zephyr masts conforms to the letter and spirit of the class rules, and advice the Executive accordingly. Burton/Retter.
- **National Contest:** Keith Smith and Trevor Cotterill confirmed their commitment to hosting the National Contest at Easter 1998. The need to appoint a Race Officer was identified, and some possibilities discussed. Waiuku were assured of the support of the ZOA.
- **Measuring**
Auckland Measurers: Bob Foster, Noel May, Ted Frankham.
Hamilton Measurer: Rob Ebert
National Contest Measuring: Some boats may need to be measured and issued with Certificates for the National Contest. The idea of surveying one aspect of the boats was floated.

Auditor

Alex Aitken asked the meeting to note that R Ineson had audited the Financial Report, and asked that he be confirmed as the Auditor. The meeting instructed the incoming Executive to check if the Auditor could be an Association official, and make the appointment.

Zephyr Owners Association President's Report

Midway through 1996 I was asked by the chairman of the Canterbury Zephyr Owners Association if I would be willing to take on the job coordinating the New Zealand structure of the ZOA. I was aware that very little had been happening since Auckland had voted to pass the reins over to Canterbury. There was a realisation at the outset that ZOA had been pushed into the background and only became relevant when there was a national competition or a need to quit cedar hulls lying unsold and eating up costs. I duly accepted the challenge, and it has been all go since then.

Membership was the first priority and this has been made possible by the revival of the West Wind and sending out copies to all known Zephyr sailors on the Register. Rob Ebert has been a real tower of strength and having computers linked with email and fax facilities makes communication so much easier.

What has been achieved during the year:

- Membership has tripled, resulting in more income.
- Four newsletters have been published
- The toll and stationery accounts reflect the PR work achieved
- The last cedar hull has been sold
- The sail design has been detailed on the computer for more accuracy
- A new boat builder is the process of being commissioned
- Contact has been made with a Zephyr Owner in

Wellington and the feedback is encouraging

- Financial statements have been filed with the Company's office so that we retain our Certificate of Incorporation
- Rob Ebert has updated the Class Rules and building code
- The President visited Auckland with Rob Ebert to establish links with past builders and designers
- The President took part in the Freshwater Regatta on Hamilton Lake and briefed the Zephyr Owners on future activities of ZOA
- A useful forum was held at the National Championships at Pigeon Bay
- The Zephyr class will feature at the Master's Games to be held in Dunedin over Waitangi weekend 1998. This will be a good promotion for the class.

My role has been one of trying to gather Canterbury, Hamilton and Auckland into the National body so that we can have unity. My thanks to Dennis Craig, Rhys Burton, Rob Ebert and the team in Christchurch for providing a sounding board for ideas. Thanks also to Richard Ineson for preparing the annual accounts and for his excellent leadership of CZOA.

Looking to the new season, there is a lot of work to be done to achieve membership levels and we should aim to have thirty Zephyrs contesting the Easter 98 Nationals at Waiuku.

Renovation Tip - Transom Vents

Transom vents are an effective way to drain water after that half capsize that fills the cockpit. Provided the bow is kept up, water rapidly drains through the stern, even in sub-planing conditions. They are easily installed in boats without a stern bulkhead, and are well worth doing. If you have a hull with a stern bulkhead, a tunnel through the buoyancy tank needs to be created, and would be difficult without the deck being removed.
