EDITORIAL

This is the Annual General Meeting issue of the West Wind. As you will see elsewhere in the issue, there are a number of issues on the go.

Sail Construction

There is not much to report since the last West Wind where we detailed the concerns about the bottom panels of the sail. As they are at present, the trial sails would not be a satisfactory replacement to our current ones. We will need to sort this out over the winter and early part of the next sailing season with more trials. We may need to queue orders for new sails or offer the old sails for a while longer, depending upon the eventual circumstances. If the solution requires a change in construction, (more time or material) then it may come at a slightly increased cost.

Hull Construction Report

We have received revised CAD drawings from Brett Bakewell-White which we are pretty happy with, bar a few minor changes. As a result, we will be talking to Robert Brooke of the Marine Industry Association when this issue goes to press about how best to get the boats built. Hopefully we will have some more to report at the AGM and via the web site.

We had thought the traditional diagonal construction, which the "Re-design" group prefers, would be of interest to the trade training environments and this may help to keep building costs down, but this remains to be seen. Robert Brooke has had considerable experience with the design and building of Sunbursts, so he should be well versed in the relevant issues.

As I have indicated, we are currently favouring a return to the traditional "look and feel" of the Zephyr, including the original method of construction, believing that this will best meet the needs of the "market place" but it remains to be seen if the skills and materials are still available or if our assumptions are valid. We have had expressions of interest in new boats already, some from owners who went to the trouble of restoring old boats, and found that the ultimate cost was much the same as the cost of purchasing a new one. We are hopeful that using the CAD drawings to produce the required shapes for bulkheads, side tanks, deck beams etc, hopefully aided by some "volume" production will reduce some of the labour costs. This is all being explored at the moment. Long term, if the class is to survive, we will need to replace many of the existing boats. Some are absolutely mint still, but many suffer from a multitude of problems that require constant attention. Maintaining an old wooden boat can be a labour of love and is not for everyone.

What about the weight?

There has been criticism of the current 57kg weight restriction, arguing that it penalises the "restorers" in the class. Glassing older hulls is a viable way of improving longevity, but a heavy cloth is usually needed with a resultant weight penalty. It may be in the long term interests of the existing boats in the class to increase the weight limit especially as most boats are in the low to mid 60 kg range, but modern construction techniques tend to be weight saving.

FROM THE PEN OF ALEX AITKEN PRESIDENT'S REPORT



This will be brief. The Annual General Meeting this year will be held at Christchurch Yacht Club on Tuesday, August 17th. Your Executive and sub-committees have had a full on year and it is set to continue by the look of the budget. Would you please study the financial report and notes and let Rob Ebert or myself know if you have any vibes. The suggested budget for the new year should enable your association to gear itself for the next decade. ZOA strength and its ability to attract new membership relies on our need to adopt new technology and at the same time retain the Zephyr as a classic boat.

Your association is aware that we need more member participation at meetings and we are advocating a move to shift the AGM to coincide with National contests. Russell Turner, Rob Ebert and Don Currie (as a sub committee) have almost completed the hull re-design and a detailed report to ZOA is expected shortly. There is a determination to explore all issues before investing funds.

As to the three test sails, indications are that the alterations made to the bottom panel require further investigation. Doyles have contracted to sort this out.

Turning to the AGM, subsidised travel to national contests, accounting packages and developing an effective web site are all on the menu.

Looking forward to the national contest at Akaroa 27th-30th January 2005 and the 50th anniversary in Auckland 2006. An announcement will be made at the Christchurch AGM. Retirement and basking in the sun on a Pacific Island (for some of us) will have to be put on the back burner.

Rule Changes

The enclosed paper on rule changes will hopefully be self explanatory and not too difficult to follow. The first set tidy up the wording, with the exception of the rules that allow for "slimmer" wooden masts. There are those in the class that still like to use wood and back themselves and new technologies to build them reliably to the same dimensions as alloy spars.

There are those in the class too, that like the traditional look of coamings behind the mast - in fact it was a contentious move some years ago to allow them to go forward. The rule change moving the coamings further back will ease the limitations on the vang angle currently experienced and make this option more viable.

In the set of rules on construction, we are seeking to allow the use of plywood for centrecases and the transom. Many cases and transoms have split over time and the timbers they were made of are less available, so ply emerges as a sensible move. We have also made a move to "allowable timbers" in order to better inform future builders.

FINANCIAL REPORT

2003-2004 Financial Year.

The statement of accounts show that both the trading and administration accounts shows deficits, but the overall picture is one of significant investment in the future of the Zephyr class. In order that you, the owners, are better informed I will detail various items.

Trading account: The cedar hull #260 was advertised and a tender of \$3300 was accepted by ZOA executive. If you look at the opening stock figure of \$9615 this included the cost of the hull at \$5063. The closing stock figure represents a clean out of stock from Doyle Sails and a minimum holding of Spars and Rigging. This has translated into a large cash asset in the ASB 50 accelerator account.

Administration costs of the trading section are in line with the increased activity.

Administration account: It is pleasing to see that we achieved budget for subscriptions. The \$2180 includes \$80 collected on behalf of the Auckland and Canterbury Associations. The figure of \$2276 for Promotion and Development is made up of hull design by Bakewell-White \$1237.50, three trial sails \$869.63, \$100 to Russell Turner, AZO Auckland to reimburse costs associated with development. Sundry promotion came to \$69.00.

Sundry travel includes \$95.63 for subscription to Yachting New Zealand and a one off payment of \$450.00 to Canterbury Zephyr Owners to subsidise travel to the Hamilton national contest in January 2004. I have included comment on this subsidy in my annual report. Honorarium for the President is voted on each year at the AGM.

One administrative item I have managed to sort out — after many letters and follow up phone calls the Association has an IRD number and we are now exempt from tax on interest received

Financial position: Our auditor, Richard Ineson, has suggested that we write off the existing building mould. ZOA Executive have approved this move. The budget for 2004/05 sets aside funds for a new jig etc.

NOTES ON THE PROPOSED BUDGET

1. Development for new hull would be treated as a one off expense. Need to build new jig and associated templates etc aided by the CAD process.
2. Sails. Allowance for extra material costs with ongoing development in association with Doyle Sails. It is envisaged that the three trial sails will ultimately be sold to reimburse costs.
3. Travel. Subject to members approval a grant to be established annually to subsidise members travelling between islands for national contests. Suggest dollar for dollar between local associations and ZOA.
4. Accounting package. To ensure that ZOA accounting practices can be transferred to future administration it is deemed necessary to find an accounting package (eg MYOB) that is adaptable with our boat register, members subscription, trading and raising invoices. Such a package would be operable for the 2004/2005 year. We have owners within the association to assist with this exercise. The Association would have to accept any costs for upgrading a system as required.
5. Web site. Most yacht clubs and classes have adopted this method of publicity. Rob Ebert is operating the ZOA site in association with the Hamilton Yacht Club and it can be picked up through YNZ. The benefit to members is associated with the number of hits and the need to update information on a regular basis. It is inevitable that costs to maintain and upgrade the site must be factored in to the annual budget.

Minutes of the Previous Meeting: The minute of the previous AGM held at the The Sand Bar, Christchurch had been previously circulated in July 2003 West Wind and were available to the meeting. They were therefore taken as read. Accepted as a true and correct record. *Ebert/Aitken*

President's Report: Previously circulated in West Wind. Alex Aitken read this at the meeting, *Accepted Aitken/Still*

Treasurer's Report: The Treasurer commented on a very active trading year and presented an audited set of accounts to the meeting. Administration of the ZOA ran at a small loss. This was reimbursed from the Trading Account surplus. *Accepted Aitken/Maddren*

Subscriptions: A Aitken confirmed that administrative costs were now exceeding subscription income and recommended an increase to \$20. *Accepted Aitken/Smith*

Budget: As circulated in July 2003 West Wind, *Accepted Still/Waterer*

General Business:

- President's Honorarium:** "That the President be allocated an honorarium of \$150 for service rendered." This was amended to \$250 (*Allen/Ebert*) and accepted by meeting.
- National Championship 2003-04:** Rob Ebert reported on Hamilton Yacht Club's progress in organising the coming season's championship. There is strong local interest and a good turn-out is expected.
- Jubilee Regatta 2006:** AZO reported little further progress, other than confirming Tamaki as the venue. They sought feedback on potential timing of the event, either late January (possibly Anniversary Weekend) or Easter. The issue will be canvassed in West Wind.
- Zephyr "Redesign":** Russell Turner outlined the activities of the Zephyr "Redesign" group over the past year. A survey of the sectional profile and rocker line of some boats had been conducted, showing a surprising degree of consistency between them and the original plans. Brett Bakewell-White has been engaged on behalf of the ZOA to produce an up to date plans and building specifications. This will involve a reassessment of some of our current building materials and the current jig. This work is ongoing and will be reported on periodically. Further consultation with the membership may be needed. This prompted a wide ranging discussion about the merits of cedar glass versus triple skin construction and the contribution of the finishing timber to the final weight. It was noted that most older boats are around 65kgs, mak-

ing the current class minimum of 57kg unrealistic. The contribution of the sheer line to the classic look of the Zephyr was confirmed and needed to be retained.

King and Queen Post Fillers: The existence of King and Queen post fillers for the centrecase was noted on most boats, but the meeting had no view on whether they should be mandatory. They did not contribute to the strength of the centrecase assembly. It was suggested that this be addressed as part of the redesign

Original Zephyr Trophy: In the course of the discussion, Noel May undertook to reproduce the original Zephyr trophy (a half size transom) for the 50th championship.

Buoyancy: The issues from the July West Wind article by Don Currie were discussed, with recognition that some Zephyrs may have compartments that are not adequately partitioned or sealed. Owners will be asked to check this important safety aspect and to check it complies with YNZ safety standards.

Locating Old Boats: Rod Slater related good success with adverts in Trade and Exchange seeking boats for new homes. It was suggested that the ZOA place an ad periodically. The success of the web site in selling older boats was noted.

- Marketing #260:** After discussion on the issues of promoting the class and selling complete or partially complete hulls it was agreed that the ZOA look at a promotional package including a complete rig (including sail) to prospective buyers.
